## Notice of Race

### 1. RULES

- 1.1. The regatta will be governed by the rules as defined in the ISAF Racing Rules of Sailing (RRS), the special regulations of Australian Sailing and by the sailing instructions for this event. The Class rules of the classes represented will apply.

### 2. ENTRIES

- 2.1 Every skipper and crew must be a member of a Club affiliated with Australian Sailing.  
2.2 This Regatta invites entries from Flying 11s and 29r classes. (The regatta will be run in conjunction with the Jack Holt Regatta and Raceboard championships).  
2.3 Eligible boats may enter on the attached entry form. It shall be lodged with Lake Cootharaba Sailing Club Inc., 24 Boreen Parade, Boreen Point Qld 4565, no later than 10.45am on Saturday 4<sup>th</sup> May 2019. It shall be accompanied with the required fee. Late entries will be accepted at the discretion of the Race Committee.

### 3. FEES

- 3.1 Series entry fee \$120.00 per boat.

### 6. COURSES

Triangle and windward-return courses as described in the sailing instructions will be used.

### 7. SCORING

- 7.1. Three races constitute a series.  
7.2. When more than four races have been completed a boat's series score will be the total of its race scores excluding its worst score.

1<sup>st</sup> all female crew

1<sup>st</sup> Junior Skipper (U16 at the time of the regatta)

1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> overall.

Other prizes may be awarded.

**9. DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk, see RRS rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
