Notice of Race

1. RULES

- 1.1. The regatta will be governed by the rules as defined in the ISAF Racing Rules of Sailing (RRS), the special regulations of Yachting Australia and by the sailing instructions for this event.

2. ENTRIES

- 2.1. The QLD Raceboard Championships will be run in conjunction with the May Day Regatta. The competition is open to sailboards which comply with the Class rules of the International Raceboard class and Windsurfer One Design class.
- 2.2. Eligible competitors may enter on the attached entry form. It shall be lodged with Lake Cootharaba Sailing Club Inc., 24 Boreen Parade, Boreen Point Qld 4565, no later than 11.30 am on Saturday 4th May 2019. It shall be accompanied with the required fee. Late entries may be accepted at the discretion of the race committee.

3. FEES

- 3.1. Series entry fees: Adults \$90.00.
Sailors under 18 years of age \$60.00.

5. SAILING INSTRUCTIONS

The sailing instructions will be available when registering.

6. COURSES

Triangle and windward-return courses as described in the sailing instructions will be used.

7. SCORING

- 7.1. One race is required to be completed to constitute a series.
- 7.2. When more than four races have been completed a boat's series score will be the total of its race scores excluding its worst score.

8. PRIZES

The first Man and Woman Queensland residents in the Raceboard class will be awarded Queensland Champions.

Other prizes may be awarded.

9. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk, see RRS rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

10. INSURANCE

Each participating boat shall be covered with a third party liability insurance of at least \$5 million.
