NOTICE OF RACE

1. RULES

The regatta will be governed by the rules as defined in the ISAF <u>Racing Rules of Sailing</u> (RRS), the <u>special regulations of Australian Sailing</u>, the <u>class rules</u> of the Windsurfer One Design class and by the sailing instructions.

2. ENTRIES

- 2.1. The competition is open to Windsurfer One Design and LT equipment which complies with the class rules of the Australian Windsurfer One Design Association. Competitors must be members of the Australian Windsurfing Association (AWA).
- 2.2. Eligible competitors may enter <u>online</u>. Payment must be received by Lake Cootharaba Sailing Club (LCSC) no later than Friday 16 October 2020 at 17:00. Late entries with late entry fees may be accepted at the discretion of the race committee.

3. FEES

\$90 for adults.

\$60 for competitors under the age of 18 years.

\$20 late entry fee.

4. SCHEDULE

Note: Time permitting, slalom and/or marathon races may be included in the regatta.		

5. SAILING INSTRUCTIONS

The sailing instructions will be emailed to participants before 2020-10-16 17:00.

There will be no briefing prior to the commencement of racing. Notices to sailors and changes to the sailing instructions will be emailed to participants and posted on the canteen window at the clubhouse.

6. COURSES

Triangle and/or windward-return courses as described in the sailing instructions will be used. Slalom and marathon courses may be used.

Informal freestyle session may be held depending on timing and conditions.

7. EQUIPMENT

- 7.1. It is the responsibility of each competitor to ensure that their equipment conforms to the current class rules, according to RRS rules 78.
- 7.2. Downhaul systems that can be adjusted whilst sailing without the need for the sail to be in the water shall not be used.
- 7.3. Outhaul systems that can be adjusted whilst sailing without the need for the sail to be in the water shall not be used.
- 7.4. The measurement committee shall determine whether equipment could breach clauses 7.2 and 7.3 and shall issue any relevant penalties.

8. SCORING

- 8.1. One race is required to be completed to constitute the competition.
- 8.2. When more than four races have been completed a boat's series score will be the total of its race scores excluding its worst score.

9. PRIZES

The first female and the first male competitor with residence in Queensland will be awarded the title Queensland Windsurfer One Design and LT Champion.

Other prizes may be awarded.

10. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk, see RRS rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

11. INSURANCE

Each participant shall be a member of <u>Australian Windsurfing</u> and the <u>Windsurfing Class Association of Australia</u> with <u>TPL insurance</u>.
