1. RULES

The regatta will be governed by the rules as defined in the ISAF Racing Rules of Sailing (RRS), the Special regulations of Australian Sailing, the International Raceboard class rules and by the sailing instructions.

2. ENTRIES

- 2.1. The competition is open to sailboards which comply with the International Raceboard class rules. WOD and LT also welcome to join in or form a division.
- 2.2. Eligible competitors must enter <u>online</u>. Registrations open 11 April 2021. Payment must be received by Lake Cootharaba Sailing Club (LCSC) no later than 11.am Saturday 1st May 2021. Late entries may be accepted at the discretion of the race committee.

3. FEES

\$60 for competitors under the age of 18 years.

Triangle and windward-return courses as described in the sailing instructions will be used.

7. SCORING

- 7.1. One race is required to be completed to constitute the competition.
- 7.2. When more than four races have been completed a competitor's series score will be the total of their race scores excluding their worst score.

The first female and the first male competitor with residence in Queensland will be awarded the title Queensland Raceboard Champion.

Other prizes may be awarded.
