# **Notice of Race**

## 1. RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS), the special regulations of Australian Sailing and the Sailing Instructions for the event.
- 1.2. The term "boat" in the following rules and instructions also includes windsurfing boards.
- 1.3. RRS rule 44.1 is changed so that the Two-Turns Penalty is replaced by a 360°-Turn Penalty, including one gybe and one tack.
- 1.4 Only for windsurfing boards: RRS rules B3 31 Touching a mark, B4 42 Propulsion, B4 50 Drinking Container and B4 44.2 360°-Turn Penalty apply. No other RRS Appendix B rules apply.

#### 2. ENTRIES

- 2.1. Entries are invited from all classes of, off the beach monohulls and multihulls and from sailboards.
- 2.2. The fleet will be divided into four divisions.

Division 1 - Multihulls

Division 2 - Monohulls.

Division 3 – All Weta.

Division 4 – All boats with YS over 150 and Beginners

2.3. Eligible boats may enter at <a href="https://lcsc.org.au/club-racing-registration/">https://lcsc.org.au/club-racing-registration/</a> prior to 01.00pm on the day of racing.

All registrations must be done online. No cash or card payments will be accepted.

#### 3. FEES

3.1. Entry fee for the events is \$20.00 for the days two races or a season entry of \$320.

#### 4. SCHEDULE:

Two races are scheduled for each day of club racing, Times and dates are available on the clubs

#### 5. SAILING INSTRUCTIONS

The sailing instructions will be posted on the Lake Cootharaba Sailing Club website at https://lcsc.org.au/club-racing/

Changes will be posted on notice board at the foot of the clubhouse stairs.

## 6. COURSES

Windward leeward & triangle courses will be used.

#### 7. PENALTY SYSTEM

For all classes RRS rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

# 8. SCORING

- 8.1. . Scoring is based on LCSC performance handicaps (PBH) and Australian Sailing Yardsticks (YS). The race committee may adjust any boat's handicap.
- 8.2. Spring, Summer and Autumn Series scores may be given for both PBH and YS results. (PBH results may not be published till end of series)

(To be eligible for PBH a minimum of 50% of races in each series must be contested  $-1^{st} 2^{nd} 3^{rd}$  on YS are excluded from final PBH results)

Club Championship scores are given for YS results only.

- 8.3 Four races are required to be completed to constitute a series.
- 8.4 When fewer than 4 races have been completed, a boats series score will be the total of her race scores.
- 8.5 When 4 to 6 races have been completed, a boats series score will be the total of her race scores excluding her worst score.
- 8.6 When 7 to 9 races have been completed, a boats series score will be the total of her race scores excluding her 2 worst scores.
- 8.7 When 10 to 12 races have been completed, a boats series score will be the total of her race scores excluding her 3 worst scores
- 8.8 When 13 to 14 races have been completed, a boats series score will be the total of her race scores excluding her 4 worst scores
- 8.9. Duty crews (OOD) will receive average points excluding DNC. This changes RRS A9.
- 8.10. A boat that did not come to the start (as described in the RRS) will be scored DNC and receive three points more than the total of boats competing in that race.
- 8.11 A boat receiving OCS, DNS, DNF, NSC, DSQ (or similar) will be scored and receive one point more than the total of boats competing in that race.
- 8.12 As per 2022 AS Yardstick the Weta is rated as a dinghy/mono and shall be scored accordingly.

# 9. PRIZES

The following prizes will be awarded based on yardstick positions:

Overall positions in each division.

**Club Champion** 

other prizes may be awarded.

## **10. DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See rule 3, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 11. TELEVISION AND PHOTOGRAPHER'S RIGHTS

Competitors give permission for video footage or photographs of themselves or their boat to be published in any media for press, editorial or advertising purposes.

#### **12. INSURANCE**

Each participating boat shall be insured with valid third-party personal and property liability insurance with a minimum cover of \$10 million per event or the equivalent. By entering the event, each competitor declares that they have the required insurance cover. LCSC will not be liable if a competitor declares that they have insurance and it subsequently transpires that this was not true.
